SET HEARING FOR VACATION OF THE NORTH/SOUTH ALLEY RIGHT-OF WAY LOCATED EAST OF AND ADJOINING 715, 719, 723 AND 729 SW 63RD STREET AND CONVEYANCE TO D. WRIGHT PROPERTIES, LLC FOR \$28,500

WHEREAS, on May 19, 2025, by Roll Call No. 25-0732, the City Council of the City of Des Moines, Iowa voted to receive and file a communication from the City Plan and Zoning Commission to vacate approximately 3,817 square feet of the north/south alley right-of-way in the vicinity of 729 Southwest 63rd Street, which is within the block bounded by Winona Avenue to the south and Tonka Avenue to the north (hereinafter "Property"), subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated at no cost to the City; and

WHEREAS, D. Wright Properties, LLC, owner of 715, 719, 723 and 729 SW 63rd Street, Des Moines, Iowa, has offered to the City of Des Moines ("City") the purchase price of \$28,500.00 for the Property to allow for assemblage with their adjoining properties, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the Property proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said Property.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:
