WHEREAS, the Finance Department seeks to issue a purchase order for one replacement 2025 Caterpillar 930 high-lift wheel loader from Ziegler Caterpillar utilizing Sourcewell contract #020223-CAT

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and,

WHEREAS, the 2025 Caterpillar 930 high-lift wheel loader is available from Ziegler Caterpillar (1500 Ziegler Drive, NW Suite 101, Altoona, IA 50009; Chris Culbertson, Branch Operations Manager) in the amount of \$249,693.12 for a 2025 Caterpillar 930 high-lift wheel loader Sourcewell contract #020223-CAT.

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

- 1. The purchase of a 2025 Caterpillar 930 high-lift wheel loader in the amount of \$249,693.12 utilizing contract #020223 is hereby approved.

To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Ziegler Caterpillar is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
