**RESOLUTION APPROVING THE PURCHASE OF ONE REPLACEMENT 2023 CAT
CB8 PAVING COMPACTOR FOR USE BY THE STREETS DIVISION OF THE
PUBLIC WORKS DEPARTMENT AND APPROVING USE OF SOURCEWELL
CONTRACT NUMBER 060122-CAT**

WHEREAS, the Finance Department seeks to issue a purchase order for a 2023 CAT CB8 Paving Compactor for use by the Streets Division of the Public Works Department; and,

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and,

WHEREAS, the 2023 CAT CB8 Paving Compactor is available from Ziegler Caterpillar (1500 Ziegler Drive, NW Suite 101, Altoona, IA 50009; Chris Culbertson, Branch Operations Manager) in the amount of \$144,000.00 utilizing Sourcewell contract #060122-CAT.

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of a 2023 CAT CB8 Paving Compactor from Ziegler Caterpillar in the amount of \$144,000.00 utilizing Sourcewell contract #060122-CAT is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Ziegler CAT is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
