RESOLUTION APPROVING THE PURCHASE OF TWO REPLACEMENT PURPOSE-BUILT, ELGIN PELICAN THREE-WHEELED, MECHANICAL BROOM STREET SWEEPERS FOR USE BY THE STREET CLEANING DIVISION OF THE PUBLIC WORKS DEPARTMENT AND APPROVING USE OF SOURCEWELL CONTRACT NUMBER 093021-ELG

WHEREAS, the Finance Department seeks to issue a purchase order for two replacement purpose-built, Elgin Pelican three-wheeled, mechanical broom street sweepers for use by the Street Cleaning Division of the Public Works Department; and,

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and,

WHEREAS, the two mechanical broom sweepers are available from Elgin Street Sweeper Company, 1300 West Bartlett Road, Elgin, IL 60120; David Panizzi, Business Development Manager and local dealer MacQueen Group, 4607 SE Rio Ct., Ankeny, IA 50021; Mike Osler, Director of Sales in the amount of \$645,031 pursuant to Sourcewell contract #093021-ELG; and,

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of two replacement purpose-built, Elgin Pelican three-wheeled, mechanical broom street sweepers from MacQueen Group utilizing Sourcewell contract #093021-ELG is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and MacQueen Group is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
