> APPROVING COMPLETION AND ACCEPTANCE OF THE SANITARY SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO PRIVATE CONSTRUCTION CONTRACT FOR 1400 BLOCK OF EAST 26TH STREET, BETWEEN THIRD DAY PLUMBING, LLC AND HUMBERTO LECHUGA AND MIGUEL MALAGON

WHEREAS, on May 20, 2024 under Roll Call No. 24-0728, the City Council approved a private construction contract in the amount of \$29,450.00, between Third Day Plumbing, LLC, Christopher Hines, Owner, 3319 East 29th Street, Des Moines, IA, 50317 as Contractor, and Humberto Lechuga and Miguel Malagon, 1807 E. 27th Street, Des Moines, IA, 50317 as Owner, for construction of Sanitary Sewer Improvements to serve the property at the 1400 Block of East 26th Street as shown on Plan File No. 642-299/300, and further granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
