**APPROVING COMPLETION AND ACCEPTANCE OF STORM SEWER IMPROVEMENTS  
SET FORTH IN AND CONSTRUCTED PURSUANT TO PRIVATE CONSTRUCTION CONTRACT FOR  
2450 FOREST AVENUE, BETWEEN ELDER CORPORATION AND  
DES MOINES INDEPENDENT COMMUNITY SCHOOL DISTRICT**

WHEREAS, on May 23, 2022 under Roll Call No. 22-0770, the City Council approved a private construction contract in the amount of \$29,986.00, between Elder Corporation, Jared R. Elder II, President, 5088 E. University Avenue, Des Moines, IA, 50327, as Contractor, and Des Moines Independent Community School District, Ian Roberts, Superintendent, 1917 Dean Avenue, Des Moines, IA, 50316, as Owner, for construction of Storm Sewer Improvements to serve the Des Moines Public School (DMPS) Stadium, located at 2450 Forest Avenue, as shown on Plan File No. 626-048/053, and further granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Storm Sewer Improvements in the amount of \$29,986.00, which have been constructed in substantial compliance with the contract documents between Elder Corporation and Des Moines Independent Community School District, which were approved under Roll Call No. 22-0770, dated May 23, 2022, be received and filed; and that completion of said Storm Sewer Improvements to serve the Des Moines Public School (DMPS) Stadium, located at 2450 Forest Avenue, as shown on Plan File No. 626-048/053, is hereby acknowledged and that said Storm Sewer Improvements are hereby accepted.
