RESOLUTION APPROVING PRELIMINARY TERMS OF AN URBAN RENEWAL DEVELOPMENT AGREEMENT WITH JDS REAL ESTATE INVESTMENTS LLC FOR THE REHABILITATION OF A 33,540 SQUARE FOOT OFFICE BUILDING AT 108 3rd STREET

WHEREAS, JDS Real Estate Investments LLC ("Developer"), represented by Jeff Stanborough, proposes to undertake the rehabilitation of a 33,540 square foot office building located at 108 3rd Street for a three story apartment building (collectively "Improvements") in the Metro Center Urban Renewal Area; and

WHEREAS, construction of the Improvements is anticipated to be completed in 2027 at an estimated total project cost of \$7,400,000.00, subject to receipt of the financial assistance identified below; and

WHEREAS, the Developer seeks reimbursement from the taxable building valuations (exclusive of land) in the following amounts: 95% in years one (1) through five (5),85% in years six (6) through ten (10), and 75% in years 10 through 15; and

WHEREAS, the Developer has provided the Office of Economic Development with a financial analysis of the project, indicating a gap between actual project costs and the project appraisal and seeks this financial assistance package to be provided from project generated tax increment as more specifically described in the accompanying Council Communication.

NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City Council hereby approves the preliminary terms of agreement as set forth in the accompanying Council Communication; and,
- 2. Directs the City Manager or his designee to negotiate final terms of agreement for future consideration by the City Council.
