**RESOLUTION APPROVING FIRST AMENDMENT TO SUPPLEMENTAL AGREEMENT #3
WITH THE IOWA COMMUNICATIONS NETWORK FOR DATA CENTER COLOCATION
SERVICES, FIBER OPTIC NETWORK HARDWARE, NETWORK CONNECTIVITY AND
HARDWARE SUPPORT**

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for design and network services requiring the purchase of additional ADVA telecommunications and colocation hardware and software components; and

WHEREAS, the requested design and network services requiring the purchase of additional ADVA telecommunications and colocation hardware and software components are available from Iowa Communications Network ("Contractor"); and

WHEREAS, on March 27, 1986, the City Council approved the State of Iowa, Department of General Services, City of Des Moines Communications Services Agreement ("Agreement"), allowing the City to obtain such services from the current Iowa Communications Network (Mark Johnson, Interim Executive Director, Chief Administrative Officer 400 East 14th Street, Grimes State Office Building, Des Moines, IA 50319), which Agreement was supplemented by City Council approval to add services on February 6, 1995, by Roll Call No. 95-508, on December 7, 1998, by Roll Call No. 98-3773, and on October 21, 2024, by Roll Call No. 24-1452; and

WHEREAS, Supplemental Agreement #3 to the Agreement provides that additional services may be provided by amendment thereto; and

WHEREAS, Contractor will provide the requested design and network services requiring the purchase of additional ADVA telecommunications and colocation hardware and software components as requested by the Information Technology Department upon approval of an amendment to Supplemental Agreement #3, in substantial form on file in the office of the City Clerk, at an estimated cost of \$49,991.08; and

WHEREAS, funding for said purchase is available from CIP FY2026, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 57; CIP FY2026, BL133, C034PK99, City Facility and Armory Replacement, Page 39.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, that:

1. The Information Technology Department and Procurement Division are hereby authorized and directed to complete negotiation of the First Amendment to Supplemental Agreement #3 with Iowa Communications Network, and the City Manager is authorized and directed to execute said Agreement on behalf of the City, following approval as to form by the Legal Department.
2. The Information Technology Department is directed to administer and monitor said First Amendment to Supplemental Agreement #3 for compliance on behalf of the City.
