APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO PRIVATE CONSTRUCTION CONTRACT, 1301 MULBERRY STREET, BETWEEN LLOYD CONSTRUCTION COMPANY AND 13TH & MULBERRY MULTIFAMILY, LLC

WHEREAS, on March 4, 2024 under Roll Call No. 24-0311, the City Council approved a private construction contract in the amount of \$45,100.00, between Lloyd Construction Company, Chris Thorkelson, President, 150 E 4th Place, Suite 600, Sioux Falls, SD, 57104, as Contractor, and 13th & Mulberry Multifamily, LLC, Chris Thorkelson, President, 150 E 4th Pl, Suite 600, Sioux Falls, SD, 57104, as Owner, for construction of Paving Improvements to serve The Deco, located at 1301 Mulberry Street as shown on Plan File No. 646-169/176, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
