**RESOLUTION APPROVING THE PURCHASE OF ONE REPLACEMENT CATCH
BASIN CLEANER COMBINATION SEWER EQUIPMENT TRUCK FOR USE BY
THE DEPARTMENT OF PUBLIC WORKS, SEWER MAINTENANCE DIVISION AND
APPROVING USE OF SOURCEWELL CONTRACT
NUMBERS 032824-MAK AND 101221-GRD**

WHEREAS, the Finance Department seeks to issue a purchase order for one replacement catch basin cleaner combination sewer equipment trucks for use by the Department of Public Works, Sewer Maintenance Division; and,

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and,

WHEREAS, the catch basin cleaner combination sewer equipment trucks consists of

- One Mack 64FR replacement sewer equipment truck chassis utilizing Sourcewell Contract No. 032824-MAK from Housby Mack (8700 SE Convenience Blvd., Ankeny, IA 50021; Kelly Housby, CEO) in the amount of \$164,160; and,
- One VACALL model AJVR 1015, 10 cubic yard/1500 gallon rear boom and hose reel to be installed by Municipal Pipe and Tool Company on the Mack 64FR replacement sewer equipment truck chassis utilizing Sourcewell Contract Number 101221-GRD from Municipal Pipe Tool Company (515 5th Street, Hudson, IA 50543; Mark Kaler, managing member, and Mike Popovich, Gradall Industries President) in the amount of \$481,946.71.

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of a catch basin cleaner combination sewer equipment truck as described above in the total amount of \$646,106.71 is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and
