## HOLD HEARING FOR CONVEYANCE OF A PERMANENT UNDERGROUND ELECTRIC EASEMENT IN CITY PROPERTY LOCATED AT 1515 HARRIET STREET TO MIDAMERICAN ENERGY COMPANY FOR THE ICON WATER TRAILS PROJECT

- 6. Upon receipt of the recorded document back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Underground Electric Easement and copies of the other documents to the Grantee.
- 7. There will be no proceeds associated with this transaction.
