HOLD HEARING FOR VACATION OF THE EAST/WEST ALLEY RIGHT-OF-WAY LOCATED IN THE VICINITY OF 232 EAST 16TH COURT AND CONVEYANCE TO LINETTE QUINTANILLA FOR \$200.00

WHEREAS, on August 4, 2025, by Roll Call No. 25-1042, the City Council of the City of Des Moines, Iowa voted to receive and file the recommendation from the City Plan and Zoning Commission that the east/west alley right-of-way in the vicinity of 232 East 16th Court, which is within the block bounded by East 16th Court and a north/south alleyway between Dean Avenue and East Court Avenue ("City Right-of-Way"), hereinafter more fully described, be vacated, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated at no cost to the City; and

WHEREAS, Linette Quintanilla, owner of 232 East 16th Court, has offered to the City of Des Moines ("City") the purchase price of \$200.00 for the vacation and purchase of the portion of alley right-of-way adjoining their property at 232 East 16th Court for assemblage with their adjoining property, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, which price reflects the fair market value of the City Property as determined by the City's Real Estate Division; and

WHEREAS, there is no known current or future public need for the City Right-of-Way proposed to be vacated and sold, and the City will not be inconvenienced by the vacation and sale of said property; and

WHEREAS, on October 20, 2025, by Roll Call No. <u>25-1399</u>, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed vacation and conveyance of the alley right-of-way be set for hearing on November 3, 2025, at 5:00 p.m. in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate and convey the alley right-of-way was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of the alley right-of-way, as described herein, are hereby overruled and the hearing is closed.
- 2. There is no public need or benefit for the alley right-of-way proposed to be vacated, and the public would not be inconvenienced by reason of the vacation of the north/south and east/west alley right-of-
