**APPROVING COMPLETION AND ACCEPTANCE OF THE
SANITARY SEWER IMPROVEMENTS SET FORTH IN AND CONSTRUCTED
PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, ALLEY LANDING,
BETWEEN REILLY CONSTRUCTION CO., INC. AND ALLEY LANDING LIMITED
PARTNERSHIP**

WHEREAS, on January 13, 2025 under Roll Call No. 25-0017, the City Council approved a private construction contract in the amount of \$35,500.00, between Reilly Construction Co., Inc., Chris R. Reilly, President, 110 E. Main Street, PO Box 99, Ossian, IA, 52161, as Contractor, and Alley Landing Limited Partnership, David Cooper Jr., President, 417 S Emerald Dr, Long Grove, IA, 52756 as Owner, for construction of Sanitary Sewer Improvements to serve Alley Landing at 2715 Douglas Avenue as shown on Plan File Number 667-101, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
