SETTING DATE OF HEARING ON LEASE AGREEMENT WITH BERGMAN ACADEMY FOR GREENWOOD BUILDING (FORMERLY THE SCIENCE CENTER OF IOWA BUILDING) AT 100 45TH STREET IN ASHWORTH PARK

- 2. A public hearing be held on Monday, December **8**, 2025, at 5:00 PM in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines Iowa. At that time the City Council will consider the above-described proposal, and any others submitted prior to or during the public hearing.
- 3. The City Clerk is hereby authorized and directed to public notice of said proposal and hearing in the form hereto attached, all in accordance with Iowa Code section 362.3.
