**APPROVING THE PURCHASE OF REPLACEMENT POOL EQUIPMENT AND  
INSTALLATION FROM WALDINGER CORPORATION USING STATE OF IOWA  
CONTRACT #21012A, AND AUTHORIZING NEGOTIATION AND EXECUTION OF  
SUPPLEMENTAL AGREEMENT WITH THE WALDINGER CORPORATION**

**WHEREAS**, the Engineering Department requested the Finance Department, Procurement Division to procure pool equipment to be procured during fiscal year 2026; and

**WHEREAS**, the Procurement Administrator has determined that the requested replacement pool equipment and installation has been competitively bid and are available from The Waldinger Corporation (PO Box 1612, Des Moines, IA 50306-1612) using State of Iowa Contract #21012A, as amended ("State of Iowa Contract"); and

**WHEREAS**, Des Moines Municipal Code Section 2-726(k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the pool equipment is being purchased from The Waldinger Corporation, in an amount not to exceed \$203,787.79 utilizing the State of Iowa Contract; and

**WHEREAS**, said purchase may require a Short Form Agreement between the City and The Waldinger Corporation, supplementing said State of Iowa Contract with terms specific to the City's procurement, with said agreement to be negotiated by the City's Finance Division and Engineering Department; and

**WHEREAS**, funding for said purchase is available from Fiscal Year (FY) 2026 Capital Improvement Budget, Parks Department, Swimming Pools and Aquatic Infrastructure, PK153, C040PK, Page 81.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa:

1. The purchase of replacement pool equipment and installation, in an amount not to exceed \$203,787.79 for fiscal year 2026, from The Waldinger Corporation, and per the terms and conditions of the above-described State of Iowa Contract, is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department, Engineering Department and Library Departments are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and The Waldinger Corporation, supplementing State of Iowa Contract #21012A with terms specific to the City's procurement, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
