RESOLUTION APPROVING THE PURCHASE OF SNOW REMOVAL EQUIPMENT AND UPFITTING COSTS FOR THREE MACK 64BR DUMP TRUCKS CONSISTING OF A FRONT PLOW, PLOW HITCH, WING PLOW, AND DUMP BODY FOR USE IN THE STREETS DIVISION OF THE PUBLIC WORKS DEPARTMENT

WHEREAS, the Finance Department seeks approval to purchase snow removal equipment for three Mack 64BR dump trucks consisting of a front plow, plow hitch, wing plow, and dump body for use by the Streets Division of the Public Works Department; and,

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and,

WHEREAS, the snow removal equipment is available from Henderson Products Inc. (916 S. 10th Street, Manchester, IA 52057, Ryan Burkle, Regional Sales Representative) in the amount of \$566,007.12 utilizing NASPO ValuePoint Master Agreement Number 240000000304 and Participating Addendum number 26068; and,

WHEREAS, the funding source will be Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of snow removal equipment and upfitting from Henderson Products Inc. (916 S. 10th Street, Manchester, IA 52057, Ryan Burkle, Regional Sales Representative) in the amount of \$566,007.12 utilizing NASPO ValuePoint Master Agreement Number 240000000304 and Participating Addendum number 26068 is approved for use by the Streets Division of the Public Works Department.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City and Murphy Tractor and Equipment is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.


