**APPROVING THIRD AMENDMENT TO THE URBAN RENEWAL DEVELOPMENT  
AGREEMENT WITH HRC NFS 1, L.L.C. AND HUBBELL REALTY COMPANY FOR THE  
GRAY'S STATION PROJECT**

**WHEREAS**, on August 14, 2017, by Roll Call Nos. 17-1407, 17-1408, and 17-1409, City Council approved final terms of an Urban Renewal Development Agreement (the "Agreement") with HRC NFS 1, L.L.C. and Hubbell Realty Company (collectively, "Hubbell") for the development of the Gray's Station area, a new mixed-use urban neighborhood south of Martin Luther King Jr. Parkway and north of the Raccoon River; and

**WHEREAS**, on December 10, 2018, City Council approved a First Amendment to the Development Agreement by Roll Call No. 18-2028 to address increased development costs; and

**WHEREAS**, on January 27, 2020, by Roll Call No. 20-0198, the City Council approved a Second Amendment to the Agreement regarding pump station access and use of a temporary trail on or near the project; and

**WHEREAS**, since the original Agreement and its amendments were approved, the Iowa legislature has made certain statutory changes affecting the availability of tax abatement and protection of certain levies on the Gray's Station project; and

**WHEREAS**, the City and Hubbell have negotiated a Third Amendment to the Agreement to address the legislative changes and attempt to provide Hubbell with an equivalent financial incentive as it would have received under the Agreement as amended prior to the legislative changes. A copy of the Third Amendment is on file in the Office of the City Clerk and available for public inspection.

**NOW THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa as follows:

1. The Third Amendment to Urban Renewal Development Agreement by and between the City and HRS NFC 1, L.L.C. and Hubbell Realty Company in the form on file in the office of the City Clerk is hereby approved;
