**HOLD HEARING FOR APPROVAL OF FIRST AMENDMENT TO LEASE
AGREEMENT BETWEEN THE CITY OF DES MOINES AND JOPPA WITH OPTION
TO PURCHASE CITY PROPERTY LOCATED GENERALLY AT 2501 MAURY
STREET**

WHEREAS, On October 20, 2025, the City of Des Moines and Joppa entered into a Lease Agreement for property generally located at 2501 Maury Street pursuant to Roll Call No. 25-1441; and,

WHEREAS, as part of the Lease Agreement, the City agreed to demolish a building known as the 1880s Building; and,

WHEREAS, the City and Joppa desire to amend the lease to allow Joppa to reevaluate the potential demolition of the 1880s Building, with the City agreeing to demolish the building if Joppa requests demolition within approximately six months of the City tendering possession of the property; and,

WHEREAS, the parties have negotiated a First Amendment to the Lease Agreement that is on file with the Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed First Amendment to Lease Agreement between the City of Des Moines and Joppa for City-owned property located generally at 2501 Maury Street, Des Moines, Iowa, as described herein, are hereby overruled and the hearing is closed.
2. The proposed first amendment to the lease is hereby approved.
3. The Mayor is authorized and directed to sign the Agreement, and the City Clerk is authorized and directed to attest to the Mayor's signature.
