**ORDERING CONSTRUCTION OF
SE INDUSTRIAL WATER MAIN – E. ARMY POST ROAD AND SE 45TH STREET
AND FIXING A DATE FOR RECEIVING OF BIDS ON JANUARY 27, 2026
AND PUBLIC HEARING ON FEBRUARY 23, 2026;
ENGINEER'S ESTIMATE IS \$3,150,000**

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached communication recommending construction of the following public improvement and the method of financing; and also including the recommendation of the Des Moines City Engineer, as the Engineer, submitting plans, specifications, form of contract documents, and Engineer's estimate of cost for the construction of the following public improvement:

SE Industrial Water Main – E. Army Post Road and SE 45th Street, Activity ID 042026008

The improvements include trenched and trenchless 12-inch and 16-inch water main installation, water service installation, partial culvert removal and replacements, full depth patching, Portland Concrete Cement (PCC) Driveways, Hot-Mix Asphalt (HMA) driveways, gravel driveways, seeding, erosion control, pavement markings, and other incidental items, all in accordance with the contract documents including Plan File No. 678-447/528, located on Hart Avenue from SE 36th Street to SE 45th Street, SE 45th Street from Hart Avenue to Pine Avenue, Army Post Road from 1,300 feet west of SE 45th Street to SE 45th Street, and Pine Avenue from SE 36th Street to SE 45th Street, Des Moines, Iowa

be and the same are hereby approved and accepted. The estimated construction cost for said public improvement is \$3,150,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

BE IT FURTHER RESOLVED: That this Council hereby determines that it is necessary and advisable to construct said public improvement in the manner set forth in the plans, specifications, and form of contract documents submitted by the Engineer; and that payment for the cost of said public improvement shall be paid from the funding source identified below.

BE IT FURTHER RESOLVED: That proposals will be received by the City of Des Moines, at the office of the Des Moines City Clerk until 11:00 a.m. on January 27, 2026, for the construction of said public improvement, and the taking of bids in the manner required by law. Proposals received will be opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa, at 11:00 a.m. on January 27, 2026, after which the bids together with a bid tabulation and recommendation of the Engineer will be presented to the City Council at its February 23, 2026 meeting for action thereon.

BE IT FURTHER RESOLVED: That a public hearing on said plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said public improvement be held in the City Council Chambers, 1st Floor, T.M. Franklin Cownie City Administration Building, 1200 Locust Street, Des Moines, Iowa, at 5:00 p.m. on February 23, 2026, at which time this Council will consider any objections offered thereto or to the making of said public improvement.
