**APPROVING AND AUTHORIZING THE EXECUTION OF THE IOWA
DEPARTMENT OF TRANSPORTATION (IDOT) AGREEMENT FOR THE
RECONSTRUCTION OF NEAL SMITH TRAIL AS PART OF THE BIRDLAND PARK
PHASE 1A IMPROVEMENTS PROJECT**

WHEREAS, the City of Des Moines Parks and Recreation Department desires to reconstruct a portion of the Neal Smith Trail as part of the Birdland Park Phase 1A Improvements - Reconstruction of the Neal Smith Trail project ("Project"),

WHEREAS, on June 30, 2025, by Roll Call No. 25-0887, the City Council approved the Parks and Recreation Department's grant application to the Iowa Department of Transportation (IDOT) State Recreational Trails (SRT) fund for financial assistance in the amount of \$200,000.00 for the Project; and

WHEREAS, the IDOT has awarded the City the amount of \$200,000 as requested in the grant application, subject to the approval of and compliance with the IDOT Agreement No. 2026-RT-001.

NOW, THEREFORE, BE, AND HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That Agreement No. 2026-RT-001 between the City of Des Moines and the Iowa Department of Transportation for the reconstruction of Neal Smith Trail as part of the Birdland Park Phase 1A Improvements project, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content.
2. That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Agreement for and on behalf of the City of Des Moines, Iowa.
