**APPROVING AND AUTHORIZING THE CITY MANAGER OR DESIGNEE TO NEGOTIATE  
AND EXECUTE A GRANT AGREEMENT WITH THE IOWA DEPARTMENT OF NATURAL  
RESOURCES FOR TREE PLANTING ACTIVITIES**

**WHEREAS**, the City of Des Moines Public Works Department, Forestry Division, has applied for and been awarded grant funding to support urban forestry initiatives within the City of Des Moines; and

**WHEREAS**, the Iowa Department of Natural Resources (hereinafter "IDNR") selected the City of Des Moines Forestry Division to receive a grant of \$30,000.00, subject to approval of and compliance with a grant agreement (hereinafter "Agreement") on file in the office of the City Clerk; and

**WHEREAS**, the grant funds will be used to support tree planting and related urban forestry activities consistent with City goals and policies; and

**WHEREAS**, the Agreement includes programmatic and compliance requirements that must be reviewed and approved prior to execution; and

**WHEREAS**, the Agreement does require the City to indemnify and hold harmless the IDNR and its designees from damages, claims, and liabilities associated with the Agreement; and

**WHEREAS**, the City's Public Works Department Director recommends approval of the Agreement and authorizing the City Manager or designee to negotiate final terms of the Agreement and to execute such Agreement, including the indemnification provision.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

1. The Grant Agreement between the City of Des Moines and the Iowa Department of Natural Resources and as further described above, is hereby approved.
2. The City Manager or designee is hereby authorized to negotiate and execute the grant agreement including the indemnification provisions, subject to approval by the Legal Department as to form.
