**RESOLUTION APPROVING THE PURCHASE AND INSTALLATION OF FURNITURE FOR  
NORTHSIDE COMMUNITY RECREATION CENTER FROM ALL MAKES OFFICE EQUIPMENT CO.  
OF DES MOINES, APPROVING USE OF OMNIA PARTNERS MASTER AGREEMENTS #R240113 AND  
#07-103, NASPO VALUEPOINT MASTER AGREEMENTS #3970 AND #3963, AND STATE OF IOWA  
PARTICIPATING ADDENDUMS #23127 AND #23128, AND AUTHORIZING  
NEGOTIATION AND EXECUTION OF SUPPLEMENTAL AGREEMENTS WITH  
ALL MAKES OFFICE EQUIPMENT CO. OF DES MOINES**

**WHEREAS**, the Facilities Division requested the Finance Department, Procurement Division to procure the acquisition and installation of office furniture at the Northside Community Recreation Center, to be known as the Reichardt Community Recreation Center (915 College Ave), as part of the City's Northside Community Recreation Center Project; and

**WHEREAS**, the Procurement Administrator has determined that the requested furniture and installation services have been competitively bid and are available from All Makes Office Equipment Co. of Des Moines, Amee Zetzman (President), 500 E. Court Avenue, Suite 1500, Des Moines, IA 50309, pursuant to OMNIA Partners Master Agreements #R240113 and #07-103, and to NASPO ValuePoint Master Agreements #3970 and #3963 and related State of Iowa Participating Addenda #23127 and #23128; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(b)(20) provides for the procurement of goods or services from contracts that have been competitively established through cooperative group contracting consortiums for State government departments, institutions, agencies and political subdivisions, such as OMNIA and NASPO ValuePoint, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the furniture and installation services will be purchased from All Makes Office Equipment Co. of Des Moines in the total amount of \$110,002.78 using the above-referenced Master Agreement and related Participating Addenda; and

**WHEREAS**, funding for said purchase is available from Fiscal Year (FY) 2026 Capital Improvement Program (CIP), Page 41, Reichardt Community Recreation Center, BL135, Being: G.O. Bonds, Local Option Sales and Service Tax (LOSST), General Fund via ARPA transfer, and Private Funds; and

**WHEREAS**, said procurement may require a Short Form Agreement(s) between the City and All Makes Office Equipment Co. of Des Moines to supplement the above-referenced Master Agreements and Participating Addenda with terms specific to the City's procurement, with said Agreement(s) to be negotiated by the City's Finance Department and Facilities Division.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa that:

1. The purchase of furniture and installation services to complete interior renovations at the Northside Community Recreation Center, at a total cost of \$110,002.78 from All Makes Office Equipment Co. of Des Moines, and per the general terms and pricing of OMNIA Partners Master Agreements #R240113 and #07-103, and of NASPO ValuePoint Master Agreements #3970 and #3963 and related State of Iowa Participating Addenda #23127 and #23128, is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Facilities Division are hereby authorized and directed to proceed with the negotiation of Short-Form Agreement(s) or similar agreement between the City and All Makes Office Equipment Co. of Des Moines, supplementing OMNIA Partners Master Agreements #R240113 and #07-103, and NASPO ValuePoint Master
