**RESOLUTION APPROVING THE PURCHASE OF TWO REPLACEMENT LIGHT DUTY TRUCKS AND ONE LIGHT DUTY LAW ENFORCEMENT SPORTS UTILITY VEHICLE FROM GL DODGE CITY IN THE TOTAL AMOUNT OF \$143,517, APPROVING USE OF STATE OF IOWA DEPARTMENT OF ADMINISTRATIVE SERVICES CONTRACTS #24052A AND 24028A, AND AUTHORIZING NEGOTIATION AND EXECUTION OF SUPPLEMENTAL AGREEMENT WITH GL DODGE CITY**

**WHEREAS**, the Des Moines Fire Department requested the Finance Department, Fleet Services Division to procure two replacement light-duty trucks and one replacement light-duty law enforcement sports utility vehicle (SUV) for Fire Department use; and

**WHEREAS**, the Fleet Services Administrator and Procurement Administrator have determined that the requested vehicles have been competitively bid and are available from GL Dodge City (12103 Hickman Road, Urbandale, IA 50323; Dan Boettcher, General Manager), pursuant to State of Iowa Department of Administrative Services (DAS) Master Agreement Nos. 24052A and 24028A; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(b)(18) provides for the procurement of goods or services from contracts established by the State of Iowa Department of Administrative Services pursuant to procedures established by Iowa Code Chapter 8A and rules and regulations promulgated thereunder, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the vehicles will be purchased from GL Dodge City in the total amount of \$143,517 using the above-referenced State of Iowa DAS agreements; and

**WHEREAS**, funding for said purchase is available from Fiscal Year (FY) 2025-2026 Recommended Operating Budget, Page 78, Equipment Replacement Fund; and

**WHEREAS**, said procurement may require a Short Form Agreement(s) between the City and GL Dodge City to supplement the above-referenced State of Iowa DAS agreements with terms specific to the City's procurement, with said Agreement(s) to be negotiated by the City's Finance Department.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa that:

1. The purchase of two replacement light-duty trucks and one replacement light-duty law enforcement SUV, at a total cost of \$143,517.00 from GL Dodge City, and per the general terms and pricing of State of Iowa DAS Master Agreement #s 24052A and 24028A, respectively, is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department is hereby authorized and directed to proceed with the negotiation of Short-Form Agreement(s) or similar agreement between the City and GL Dodge City, supplementing State of Iowa DAS Master Agreement #s 24052A and 24028A, and the City Manager is authorized and directed to execute said Agreement(s) on behalf of the City following approval as to form by the Legal Department.
