APPROVING ADDITIONAL FUNDS FOR PURCHASE OF AUTO BODY REPAIR SERVICES FOR VARIOUS CITY DEPARTMENTS FROM GL DODGE CITY LLC (STEW HANSEN DODGE CITY) FOR AN ADDITIONAL \$120,000 FOR FISCAL YEAR 2026

WHEREAS, on July 15, 2024, by Roll Call No. 24-0987, the City Council approved funding of an annual agreement for auto body repair services including labor and parts with GL Dodge City LLC (Stew Hansen Dodge City, 12103 Hickman Road, Urbandale, IA 50323, Dan Boettcher, General Manager) using State of Iowa Department of Administrative Services (DAS) Contract No. 22044D (“DAS Contract”), and the City further entered into Short-Form Agreement No. K22-304 with Stew Hansen Dodge City with renewal options through September 13, 2026; and

WHEREAS, on February 24, 2025, by Roll Call No. 25-0292, the City Council approved the purchase of auto body repair services for various City Departments from GL Dodge City LLC (Stew Hansen Dodge City) for an additional \$150,000.00 for Fiscal Year 2025 and authorized continued use of the DAS Contract, and further directed the Finance Department to proceed with the issuance of a blanket purchase order for Fiscal Year 2026; and

WHEREAS, the Fleet Services Administrator is now requesting additional funding in the amount of \$120,000.00 to accommodate projected auto body repair services including labor and parts from GL Dodge City LLC (Stew Hansen Dodge City) for the remainder of Fiscal Year 2026, allowing Fleet Services to coordinate future vehicle repairs for various City Departments using the DAS Contract and the Short-Form Agreement; and

WHEREAS, funding is available from Fiscal Year 2025-2026 Recommended Operating Budget, Page 87, Equipment Maintenance Center Fund.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, approves the increase of \$120,000.00 in Fiscal Year 2026 for auto body repair services from GL Dodge City LLC (Stew Hansen Dodge City) using the DAS Agreement and Short-Form Agreement No. K22-304.
