WHEREAS, on December 6, 2021 under Roll Call No. 21-1796, the City Council approved a private construction contract in the amount of \$85,812.00, between Ryan Companies US, Inc., Brian Murray, CEO, 111 East Grand Ave., Suite 200, Des Moines, IA, 50309 as Contractor, and US General Services Administration, Heartland Region 6, Michael Flanigan, Manager, 2300 Main St., 7th Floor, Kansas City, MO, 64131 as Owner, for construction of storm sewer improvements to serve the Federal Courthouse located at 101 Locust Street, as shown on Plan File No. 603-205/208, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
