**RESOLUTION APPROVING AGREEMENT FOR CYBER SECURITY SOLUTIONS AND PROFESSIONAL SERVICES FROM TD SYNnex CORPORATION, AND APPROVING THE USE OF OMNIA PARTNERS/REGION 4 ESC CONTRACT #R250307**

**WHEREAS**, the Information Technology Department has an immediate and ongoing need for cyber security and professional services for various projects supporting City Departments; and

**WHEREAS**, on June 9, 2025, by Roll Call No. 25-0848, the City Council approved the purchase of phone system implementation consulting and professional services, in an amount not to exceed \$285,000.00, from Carrier Access IT (Chad Kruse, President/CEO; 1275 Northwest 128th Street, #210, Clive, IA 50325), an authorized subcontractor of TD SYNnex Corporation, pursuant to the general terms and pricing of Omnia Contract #R200803 and City of Des Moines Short Form Agreement #K25-336; and

**WHEREAS**, Omnia Contract #R200803 and supplementing City of Des Moines Short Form Agreement #K25-336 have expired as of March 1, 2026, and Omnia Contract #R250307 has been issued as a replacement contract with TD Synnex Corporation; and

**WHEREAS**, the Information Technology Department and Procurement Division have negotiated supplemental City of Des Moines Short Form Agreement #K26-228 between the City of Des Moines and TD Synnex Corporation for a term concurrent with the replacement OMNIA contract, with each service acquired pursuant to said Agreements to be approved in accordance with Procurement Ordinance requirements; and

**WHEREAS**, Des Moines Municipal Code Section 2-726(b)(20) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Des Moines, Iowa, that:

1. Short-Form Agreement #K26-228 between the City and TD Synnex Corporation supplementing Omnia Contract # R250307, in form on file in the office of the City Clerk, is hereby approved, and the Mayor is authorized and directed to execute said Agreement on behalf of the City.
2. The Information Technology Department Manager and designee are directed to administer said Agreement on behalf of the City, and to negotiate purchases from TD Synnex Corporation pursuant to said Agreement, subject to approval as to form by the Legal Department and presentation to Council or to the City Manager for consideration and approval in accordance with the Procurement Ordinance.
