HEARING AND ADOPTION OF AMENDED MUNICIPAL HOUSING AGENCY ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2026

3. The Municipal Housing Agency's amended annual budget for the fiscal year ending June 30, 2026, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
4. The Mayor and the City Clerk are hereby directed to execute and certify the Municipal Housing Agency's amended budget for the fiscal year ending June 30, 2026, to the Des Moines City Council for incorporation into the City's fiscal year 2026 amended budget to be certified to the State of Iowa.
