WHEREAS, the Des Moines Municipal housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED, by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2026, and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2027, on the forms on file in the Office of the City Clerk and the Neighborhood Services Director is hereby directed to submit such certifications to the U.S. Department of Housing and Urban Development.
