RESOLUTION APPROVING THE PURCHASE OF A FLYGT SUBMERSIBLE PUMP FOR THE SE 15TH STREET AND HARRIET STREET STORMWATER PUMP STATION FROM ELECTRIC PUMP & TOOL SERVICES, INC. PURSUANT TO CITY OF DES MOINES SHORT FORM AGREEMENT #J23-221

WHEREAS, the Public Works Department's Sewers Division has requested Finance Department's Procurement Division to issue a purchase order for a Flygt submersible pump for the SE 15th Street and Harriet Street stormwater pump station; and

WHEREAS, on June 26, 2022, by Roll Call No. 22-1027, the City Council approved the negotiation and execution of a Short Form Agreement between the City of Des Moines and Electric Pump & Tool Services, Inc., 4280 E 14th Street, Des Moines, IA 50313, President, Tom Miller; and

WHEREAS, the Flygt submersible pump is available from Electric Pump & Tool Services, Inc., pursuant to Short Form Agreement #J23-221 in the amount \$119,584.00; and

WHEREAS, funding is available from Fiscal Year (FY) 2026-2027 Operating Budget, Public Works, PW247414-526030.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves the purchase of a Flygt submersible pump for the SE 15th and Harriet stormwater pump station from Electric Pump & Tool Services, Inc., 4280 E 14th Street, Des Moines, IA 50313, President, Tom Miller, in the total amount of \$119,584.00 pursuant to Short Form Agreement #J23-221.
