RESOLUTION DISMISSING HEARING ON APPROVAL OF PLANS, SPECIFICATIONS, FORM OF CONTRACT, AND ENGINEER'S ESTIMATE ON THE 2026 SANITARY SEWER REPLACEMENT PROGRAM, DUE TO CANCELLATION OF BID PROCESS

WHEREAS, on February 23, 2026, under Roll Call No. 26-0220, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following public improvement:

2026 Sanitary Sewer Replacement Program, Activity ID 072026001

The improvement includes removals, sanitary sewer installation, storm sewer installation, intake replacement, replacement of driveways, sidewalks, Portland Cement Concrete (PCC) and Hot-Mix Asphalt (HMA) pavement, traffic control, erosion control, restoration, seeding, and other miscellaneous work, all in accordance with the contract documents including Plan File No. 679-262/283, located at 42nd Street and Madison Avenue, and 24th Street and College Avenue in Des Moines, Iowa; and

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law; and

WHEREAS, on March 6, 2026, the City Engineer issued a Cancellation Notice on the project that cancelled the bid process and the March 10, 2026 bid date, due to the work being rescheduled for completion under the 2025 Sewer Lining Program project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that due to the bids being cancelled for the above referenced public improvement, this hearing is hereby dismissed.
