**RESOLUTION DEDICATING GRAND AVENUE AND 45<sup>TH</sup> STREET RIGHT-OF-WAY LOCATED BETWEEN 45<sup>TH</sup> STREET AND 49<sup>TH</sup> STREET**

**WHEREAS**, a Plat of Survey has been prepared and recorded that identifies the necessary right-of-way limits for dedication of the Grand Avenue right-of-way and 45<sup>th</sup> Street right-of-way located between 45<sup>th</sup> Street and 49<sup>th</sup> Street.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa:

1. The Plat of Survey recorded in the office of the Polk County Recorder in Book 20506, Page 665 of the Grand Avenue and 49<sup>th</sup> Street right-of-way is hereby approved and the parcel of City-owned land described in said Plat of Survey as dedicated for street purpose is hereby dedicated as public right-of-way for Grand Avenue and 49<sup>th</sup> Street:

A PART OF THE WEST 1/2 OF THE NORTHEAST 1/4 OF SECTION 12 AND A PART OF SECTION 1, ALL IN TOWNSHIP 78 NORTH, RANGE 25 WEST OF THE 5TH P.M., NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA AND DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTH 1/4 CORNER OF SAID SECTION 12; THENCE SOUTH 89°(DEGREES) 43'(MINUTES) 23"(SECONDS) EAST ALONG THE NORTH LINE OF SAID NORTHEAST 1/4 AND ALSO BEING A LINE 33.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF POLK PLACE, AN OFFICIAL PLAT, A DISTANCE OF 308.31 FEET; THENCE NORTH 77°09'27" EAST CONTINUING ALONG A LINE BEING 33.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF SAID POLK PLACE AND ALSO BEING RE-PLATTED AS INGERSOLL PARK, AN OFFICIAL PLAT, 562.78 FEET; THENCE SOUTH 80°22'50" EAST CONTINUING ALONG A LINE BEING 33.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF SAID POLK PLACE AND ALSO BEING RE-PLATTED AS INGERSOLL PARK, 115.50 FEET; THENCE SOUTH 71°00'50" EAST CONTINUING ALONG A LINE BEING 33.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF SAID POLK PLACE AND ALSO BEING RE-PLATTED AS INGERSOLL PARK, 339.79 FEET; THENCE SOUTH 89°43'23" EAST CONTINUING ALONG A LINE BEING 33.00 FEET SOUTH OF AND PARALLEL TO THE SOUTH LINE OF SAID POLK PLACE AND ALSO BEING RE-PLATTED AS INGERSOLL PARK, 31.32 FEET TO THE NORTHEAST CORNER OF SAID WEST 1/2 OF THE NORTHEAST 1/4;

FT.)
