RESOLUTION APPROVING ADDITIONAL FUNDING IN THE ESTIMATED AMOUNT OF \$64,670 FOR ANNUAL TELEPHONE SERVICE FEES AND THE UNIFIED COMMUNICATIONS UPGRADE CIP PROJECT, PROCURED UNDER A THREE-YEAR AGREEMENT WITH QWEST CORPORATION D/B/A CENTURYLINK, FOR AN ESTIMATED TOTAL OF \$634,760 THROUGH FISCAL YEAR 2026

WHEREAS, the Information Technology Department previously requested the Finance Department's Procurement Division to issue a purchase order for the purchase of telephone services and associated fees; and

WHEREAS, on June 26, 2023, by Roll Call No. 23-0924, the City Council approved the purchase of basic telephone services from Qwest Corporation d/b/a CenturyLink, 2100 CenturyLink Dr., Monroe, LA (Glen Post, CEO), in an amount not to exceed \$190,000.00 annually for a period of up to three (3) years; and

WHEREAS, additional spending in the estimated amount of \$64,670.00 is anticipated for the remainder of fiscal year 2026 due to additional telephone service fees and the construction and installation of a redundant telecommunications circuit Session Initiation Protocol (SIP) trunk at the Municipal Service Center (1551 E Martin Luther King Jr. Parkway); and

WHEREAS, the FY2026 funding for the additional telephone service fees and the construction and installation of a redundant telecommunications circuit Session Initiation Protocol (SIP) trunk is available from the following sources:

\$221,760 from FY 2026 Operating Budget, Information Technology Department, Telephone Communications, I033, IT154000, Page 131

\$33,000 from CIP funds, Enterprise Communications and Data Management Systems, Roll Call #21-1260, items 52 and 52A and Roll Call #25-1160, item 47. FY2027 Recommended CIP Budget, MS001 Enhanced Information and Communication System, page 54.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional estimated expenditure of \$64,670.00, with a total estimated amount of \$634,760.00 for a three (3)-year period through Fiscal Year 2026 for additional telephone service fees and the construction and installation of a redundant telecommunications circuit Session Initiation Protocol (SIP) trunk at the Municipal Service Center (1551 E Martin Luther King Jr. Parkway) to be procured from Qwest Corporation d/b/a CenturyLink, 2100 CenturyLink Dr., Monroe, LA (Glen Post, CEO), is hereby approved.
