SET HEARING FOR RELEASE OF TEMPORARY STORMWATER FACILITY EASEMENT GENERALLY LOCATED WITHIN LOT 1 OF THE CREEK AT ECHO VALLEY PLAT 1

WHEREAS, the City of Des Moines, Iowa (the “City”), is the holder of a certain Temporary Stormwater Facility Easement (the “Temporary Easement”) associated with property legally described as follows:

A PART OF THE NORTHEAST FRACTIONAL QUARTER OF THE NORTHEAST QUARTER OF SECTION 6, TOWNSHIP 77 NORTH, RANGE 24 WEST OF THE FIFTH PRINCIPAL MERIDIAN IN THE CITY OF DES MOINES, WARREN COUNTY, IOWA AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF LOT 1, THE CREEK AT ECHO VALLEY PLAT 1, AN OFFICIAL PLAT IN SAID CITY OF DES MOINES; THENCE NORTH 81°35’11” EAST ALONG THE SOUTHERLY LINE OF SAID THE CREEK AT ECHO VALLEY PLAT 1, A DISTANCE OF 60.00 FEET TO THE SOUTHEAST CORNER OF SAID THE CREEK AT ECHO VALLEY PLAT 1; THENCE SOUTH 87°33’11” EAST, 53.77 FEET; THENCE SOUTH 24°19’05” EAST, 87.83 FEET; THENCE SOUTH 11°46’28” WEST, 40.66 FEET; THENCE SOUTH 55°04’17” WEST, 40.66 FEET; THENCE SOUTH 77°57’31” WEST, 20.00 FEET; THENCE NORTH 60°22’39” WEST, 43.62 FEET; THENCE NORTH 13°08’18” WEST, 53.73 FEET; THENCE NORTH 39°48’13” WEST, 52.07 FEET; THENCE NORTH 09°39’20” WEST, 27.31 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.34 ACRES (14,807 SQUARE FEET).

(the “Easement Area”)

WHEREAS, the Temporary Easement was granted for temporary stormwater management purposes, which have been fulfilled by the construction of a permanent stormwater detention facility; the City has determined there is no current or anticipated future public need for the Easement Area, and release of the Temporary Easement will not inconvenience the public; and

WHEREAS, Iowa Code § 364.7 requires that before a City may release any interest in real property, the City Council must publish notice of the proposed action and hold a public hearing thereon; and

WHEREAS, the City Council desires to set a public hearing on the proposed release of the Temporary Easement in conformance with the requirements of Iowa Code § 364.7;
