RESOLUTION APPROVING PRELIMINARY TERMS OF AN URBAN RENEWAL DEVELOPMENT AGREEMENT WITH GREATER DES MOINES HABITAT FOR HUMANITY, INC. FOR THE CONSTRUCTION OF A MULTIFAMILY RESIDENTIAL PROJECT LOCATED AT 6100 HICKMAN ROAD

WHEREAS, Greater Des Moines Habitat for Humanity, Inc. (“Developer”) represented by Ryan Doyle, Director of Real Estate & Land Development, proposes to undertake a new construction project at 6100 Hickman Road (the “Improvements”) to be located in a future urban renewal area (to be considered at a future City Council meeting); and

WHEREAS, the total project cost of the Improvements is estimated to cost \$6,200,000.00, subject to receipt of the financial assistance identified below; and

WHEREAS, the Developer seeks reimbursement from the taxable building valuations (exclusive of land) in an amount equal to 100% of the tax increment for eleven (11) years, not to exceed \$674,000.00 on a net present value basis at a 4.5% discount rate; and

WHEREAS, the Developer has provided the Office of Economic Development with a financial analysis of the project, indicated a financial gap between the project appraisal and anticipated mortgage origination amount, and seeks this financial assistance package to be provided from project-generated tax increment as more specifically described in the accompanying Council Communication.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby approves the preliminary terms of an agreement as set forth in the accompanying Council Communication; and
2. Directs the City Manager or his designee to negotiate final terms of an agreement for future consideration by the City Council.
