RESOLUTION APPROVING SECOND AMENDMENT OF 28E AGREEMENT BETWEEN THE CITY OF DES MOINES, CITY OF WEST DES MOINES, POLK COUNTY, CENTRAL IOWA COMMUNITY LAND TRUST, AND HOME OPPORTUNITIES MADE EASY, INCORPORATED FOR PROVISION OF SERVICES OF A COMMUNITY LAND TRUST

WHEREAS, on December 19, 2024, the Community Land Trust Advisory Committee concluded its work and issued a summary report of recommendations including proceeding with forming a community land trust and negotiating with Home Opportunities Made Easy, Incorporated (HOME, Inc.) to provide contracted operations services to establish and operate a community land trust; and

WHEREAS, on February 24, 2025, by roll call 25-0274 the City of Des Moines approved entering into a 28E Agreement between the City of Des Moines, City of West Des Moines, Polk County, and HOME, Inc. for the establishment and initial operations of the Central Iowa Community Land Trust; and

WHEREAS, on March 28, 2025, the Central Iowa Community Land Trust incorporated as a not-for-profit corporation with the Iowa Secretary of State's office; and

WHEREAS, the 28E Agreement was amended and filed with the Secretary of State on October 2, 2025; and

WHEREAS, the 28E Agreement is currently set to expire June 30, 2026, and the parties have agreed that a one year extension of the 28E would be beneficial to all parties; and

WHEREAS, now that it has been incorporated, the Central Iowa Community Land Trust should be a party to the 28E Agreement; and

WHEREAS, the parties have negotiated, agreed upon, and drafted an amendment to the 28E Agreement extending the termination date and adding the Central Iowa Community Land Trust as a party and a copy of the Amendment is attached hereto; and

WHEREAS, on May 18, 2026, the City Council of West Des Moines approved amending the 28E Agreement; and

WHEREAS, Central Iowa Community Land Trust and HOME, Inc. have approved the amendment to the 28E agreement; and

WHEREAS, the Polk County Board of Supervisors is expected to consider and act upon the amendment at its next regular meeting.
