APPROVAL OF AGREEMENT WITH THE IOWA ASSOCIATION OF MUNICIPAL UTILITIES TO PROVIDE SERVICES RELATING TO SAFETY IN THE WORKPLACE AND APPROVING EXCEPTION TO THE PROCUREMENT ORDINANCE COMPETITIVE PROCUREMENT PROCESS FOR NON-PROFIT ASSOCIATIONS

WHEREAS, Roll Call No. 23-0600, dated April 24, 2023, the City of Des Moines entered into an agreement with the Iowa Association of Municipal Utilities (IAMU) for employee safety services; and

WHEREAS, the current agreement with IAMU will expire on June 30, 2026 and the City desires to enter into a new five year agreement at a cost to the City of Des Moines in the first year of \$174,060, in the second year of \$181,020, in the third year of \$186,444, in the fourth year of \$191,100 and in the fifth year if \$195,876 as described in the associated Council Communications; and

WHEREAS, beginning with year six, the agreement shall automatically renew for additional one-year terms through June 30, 2036, unless the agreement is terminated; and

WHEREAS, the Des Moines Municipal Code Section 2-710 (a) allows for the procurement of goods and/or services through which nonprofit associations, established to aid or assist governmental bodies or other governmental agencies have secured special rates or provisions for the purchase of goods and/or services for the benefit of governmental bodies or agencies; and

WHEREAS, funding for said procurement is available from the Human Resources operating budget.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:

- 1. The Agreement between the City of Des Moines and Iowa Association of Municipal Utilities. is approved, the City Manager is hereby authorized and directed to execute said document.
