APPROVING IOWA DEPARTMENT OF TRANSPORTATION AGREEMENT FOR MAINTENANCE OF PRIMARY ROADS IN MUNICIPALITIES, AND APPROVING SUPPLEMENTAL AGREEMENT THERETO INCLUDING EMERGENCY MAINTENANCE OF STATE OF IOWA OWNED TRAFFIC SIGNALS, FROM JULY 1, 2026 TO JUNE 30, 2031

WHEREAS, the City of Des Moines maintains approximately 75 miles of State-owned roadways in Des Moines, and the Iowa Department of Transportation (IDOT) further maintains certain improvements within the City such as freeways and primary highways, pursuant to agreement between the City and IDOT which expires on June 30, 2026; and

WHEREAS, to replace the expiring agreement, the IDOT has submitted an Agreement for Maintenance and Repair of Primary Roads in Municipalities, and a Supplemental Agreement thereto including emergency maintenance of State of Iowa owned traffic signals, providing for the IDOT to pay the City an annual amount of \$199,867.04, plus additional maintenance costs and administrative fees as applicable, in exchange for the City's maintenance work as set forth in said Agreements from July 1, 2026 through June 30, 2031; and

WHEREAS, the City concurs with the terms and conditions of said Agreements for maintenance and repair of primary roads and emergency maintenance for traffic signals, from July 1, 2026 through June 30, 2031, in negotiated form on file in the office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, that the Agreement for Maintenance and Repair of Primary Roads in Municipalities between the City of Des Moines and the Iowa Department of Transportation, and the Supplemental Agreement thereto including emergency maintenance for traffic signals within the City of Des Moines, with compensation to the City in the annual amount of \$199,867.014 for routine road maintenance, actual costs plus a 10% administrative fee for emergency traffic signal maintenance, through June 30, 2031, be and is hereby approved; the Mayor is authorized and directed to sign said Agreements on behalf of the City; and the Public Works Department Director and his designee are authorized and directed to administer and monitor said Agreements.
