BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer, showing the cost of the construction of the 2025 Midblock Pedestrian Signal Improvements, Activity ID 042024005 ("Project"), in accordance with the contract approved under Roll Call No. 24-1532, of November 04, 2024, between Kline Electric, Inc. d/b/a Heartland Underground Solutions, Shane T. Kline, President, 6355 NE 14th Street, Des Moines, IA, 50313, and the City of Des Moines, and recommending the acceptance thereof, be and the same is hereby approved, and the construction of the Project is accepted.

BE IT FURTHER RESOLVED: That \$393,505.96 is the total cost, of which \$381,700.78 has been paid the Contractor, and \$11,805.18 is now due and is hereby approved as final partial payment for the above project, the remaining balance of \$0.00 is to be paid at the end of thirty days, with funds retained for unresolved claims on file in accordance with Iowa Code Chapter 573.

BE IT FURTHER RESOLVED: That the Director of Finance be and is hereby authorized to release said retainage if suit is not filed as above provided.
