**ACCEPTANCE OF PROPOSAL FROM
MIDAMERICAN ENERGY COMPANY TO
INSTALL NEW STREETLIGHTS FOR THE
GRAY'S STATION ROADWAY IMPROVEMENTS AT
SW 16th STREET AND TUTTLE STREET PROJECT,
ESTIMATED AT \$369,869.40**

WHEREAS, roadway improvements at Gray's Station at SW 16th Street and Tuttle Street requires installing 28 new streetlight poles; and

WHEREAS, MidAmerican Energy Company has submitted a proposal to the City to install the streetlight poles; and

WHEREAS, the proposal provides that MidAmerican Energy Company's estimated cost to replace and install the street light poles, which cost will be paid by City to MidAmerican Energy Company pursuant to the proposal, is \$369,869.40; and

WHEREAS, the proposal further provides that because the estimated cost of construction exceeds \$100,000, the City is required by tariff to pay actual costs upon completion of the work, which could result in an increase or decrease in the estimated cost of \$369,869.40 to be paid by the City, and the City is further required to pay actual permit fees.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the proposal from MidAmerican Energy Company to the City of Des Moines for installing 28 new streetlight poles for Gray's Station Roadway Improvements at SW 16th Street and Tuttle Street, a copy of which is now on file in the office of the City Clerk, is hereby approved as to form and content, and accepted.
2. That the City Engineer. is hereby authorized and directed to sign the proposal on behalf of the City of Des Moines.
3. That the Engineering Department is authorized to administer the terms specified in the proposal.
4. That the Finance Director is authorized to make payment to MidAmerican Energy Company for the actual costs, as described hereinabove, upon receipt of an invoice acceptable to the Engineering Department.
