**APPROVING THE PURCHASE OF RAPID7 MANAGED THREAT COMPLETE
SUBSCRIPTION FROM INSIGHT PUBLIC SECTOR, USING OMNIA AGREEMENT #23-6692-
03 AND CITY OF DES MOINES SHORT FORM #K24-449, IN AN AMOUNT NOT TO EXCEED
\$183,225.00 ANNUALLY FOR A PERIOD OF UP TO 5 YEARS**

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of Rapid7 Managed Threat Complete Subscription; and

WHEREAS, the Procurement Administrator has determined that the requested Rapid7 Managed Threat Complete Subscription is available from Insight Public Sector (Jack Azagury, President and CEO, 2701 E. Insight Way, Chandler, AZ 85286) using Omnia Contract #23-6692-03 and City of Des Moines Short Form Agreement #K24-449; and

WHEREAS, Des Moines Municipal Code Section 2-726(m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Rapid7 Managed Threat Complete Subscription is being purchased from Insight Public Sector, in an amount not to exceed \$183,225.00 annually, which amount reflects the quoted cost of \$174,500.00 plus an estimated overage of up to five percent (5%) or \$8,725.00, for a period of up to 5 years, utilizing the above-referenced Omnia Contract and City of Des Moines Short Form Agreement; and

WHEREAS, funding for said purchase is available from Operating Budget Infrastructure Management G001 IT150000 General Fund FY27 Page 107.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The purchase of Rapid7 Managed Threat Complete Subscription, in an amount not to exceed \$183,225.00 annually, for a period of up to 5 years, from Insight Public Sector, and pursuant to the general terms and pricing of Omnia Contract #23-6692-03 and City of Des Moines Short Form Agreement #K24-449, is hereby approved.
2. The Information Technology Department Director is hereby authorized to approve and to sign any scope of work, implementing or license agreements with Insight Public Sector, subject to approval as to form by the Legal Department.
