WHEREAS, the low dollar compliant bid for mowing and trimming services for Glendale Cemetery Sections 1 through 5 was received from Stamper Lawn Care, 125 Hughes Avenue, Des Moines, IA 50315, Cody Stamper, Owner; and

WHEREAS, the low dollar compliant bid for mowing and trimming services for northwest region parks, open spaces, municipal builds and Woodland Cemetery was received from ADA Mowing, 4432 Orchard Drive, Pleasant Hill, IA 50327, Joel Huggins, Owner; and

WHEREAS, funding is available from FY 2025 Operating Budget, Park and Recreation Department, Horticultural Maintenance, G001 PK200226 and Cemeteries, G001 PK200220 at an estimated annual amount of \$1,179, 046.00; and

WHEREAS, the Procurement Administrator, and Parks and Recreation Department recommends approval of the awards to the low dollar compliant bids received for mowing, trimming and litter removal services.
