WHEREAS, on January 13, 2025, under Roll Call No. 25-, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Van Maanen Electric, Inc., Newton, IA - Low Bid


