RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION FOR CENTER AT SIXTH, CONSTRUCTION OF A MIXED-USE RESIDENTIAL AND COMMERCIAL DEVELOPMENT LOCATED AT 1760 6TH AVENUE, METRO CENTER URBAN RENEWAL PROJECT

WHEREAS, on December 4, 2023, by Roll Call No. 23-1691, the City Council approved an Urban Renewal Agreement for construction of a mixed-use residential and commercial development located at 17606th Avenue between the City and Center at Sixth ("Developer"), which agreement was recorded in the office of the Polk County Recorder in Book 19676, Page 576 ("Development Agreement") for the property legally described as follows:

Lot 2 in Block 5 of the Official Plat of the SW 1/4 of the NE 1/4 of Section 34, Township 79 North, Range 24, West of the 6th P.M., (also known as POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION), an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

AND

Lot 3 in Block 5 of the Official Plat of the SW 1/4 of the NE 1/4 of Section 34, Township 79 North, Range 24, West of the 5th P.M., (also known as POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION), an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

AND

Lot 4 (except the West 30 feet of the North 20 feet) in Block 5 of the Official Plat of the SW 1/4 of the NE 1/4 of Section 34, Township 79 North, Range 24, West of the 5th P.M., (also known as POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION), an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

AND

The West 30 feet of the North 20 feet of Lot 4 in Block 5 of the Official Plat of the SW 1/4 of the NE 1/4 of Section 34, Township 79 North, Range 24, West of the 5th P.M., (also known as POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION), an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

AND

Lot 6 in Block 5 of the Official Plat of the SW 1/4 of the NE 1/4 of Section 34, Township 79 North, Range 24, West of the 5th P.M., (also known as POLK COUNTY HOMESTEAD AND TRUST CO'S ADDITION), an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

; and

WHEREAS, the terms of the Development Agreement provide that the City shall issue the Certificate of Completion upon the City's determination of satisfactory completion of the development Improvements and the Developer has requested that the Certificate of Completion for the project be issued; and

WHEREAS, City staff has inspected the development improvements and found the Improvements have been completed in substantial compliance with the terms of the Development Agreement; and
