**RESOLUTION APPROVING THE PURCHASE OF CISCO  
SMARTNET SUPPORT SERVICES FROM HEARTLAND  
BUSINESS SYSTEMS, USING THE STATE OF IOWA AGREEMENT #21294  
AND NASPO VALUEPOINT AGREEMENT #AR3227**

**WHEREAS**, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of Cisco SmartNet support services for data center network equipment to be co-termed with the current Cisco SmartNet agreement; and

**WHEREAS**, the Procurement Administrator has determined that the requested Cisco SmartNet support services for data center network equipment have been competitively bid and are available from Heartland Business Systems (Peter Helander, President, 108 3rd St, Suite 300, Des Moines, IA 50309) using NASPO ValuePoint Master Agreement #AR3227 ("NASPO Agreement") and State of Iowa Participating Addendum #21294 ("State Contract"); and

**WHEREAS**, Des Moines Municipal Code Section 2-726(b)(18) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance, and Section 2-726(b)(20) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the Cisco SmartNet support services for data center network equipment are being purchased from Heartland Business Systems in the total amount, of \$259,203.36 through August 2027, utilizing the NASPO Agreement and State Contract and to run concurrently with the City's existing SmartNet services; and

**WHEREAS**, funding for said purchase is available from Capital Improvement Program (CIP) Fiscal Year (FY) 2025, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 36 and CIP FY2025, BL133, C034PK99, City Facility and Armory Replacement, Page 62.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Des Moines, Iowa, that:

1. The purchase of Cisco SmartNet support services for data center network equipment, in the total amount of \$259,203.36, from Heartland Business Systems and pursuant to the general terms and pricing of NASPO ValuePoint Master Agreement #AR3227 and State of Iowa Participating Addendum #21294, is hereby approved.
