WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of Cisco Catalyst 9400 network hardware and Cisco Wireless 9100 access points; and

WHEREAS, the Procurement Administrator has determined that the requested Cisco Catalyst 9400 network hardware and Cisco Wireless 9100 access points have been competitively bid and are available from Heartland Business Systems (Peter Helander, President, 108 3rd St, Suite 300, Des Moines, IA 50309) using NASPO ValuePoint Master Agreement #AR3227 ("NASPO Agreement") and State of Iowa Participating Addendum #21294 ("State Contract"); and

WHEREAS, the Cisco Catalyst 9400 network hardware and Cisco Wireless 9100 access points are being purchased from Heartland Business Systems in the total amount, of \$319,641.87 utilizing the NASPO Agreement and State Contract; and

WHEREAS, funding for said purchase is available from CIP FY2025, BL133, C034PK99, City Facility and Armory Replacement, Page 50.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, that:

- 1. The purchase of Cisco Catalyst 9400 network hardware and Cisco Wireless 9100 access points, in the total amount of \$319,641.87 from Heartland Business Systems and pursuant to the general terms and pricing of NASPO ValuePoint Master Agreement #AR3227 and State of Iowa Participating Addendum #21294, is hereby approved.
