Frank to the position of Deputy City Attorney I—Infrastructure, effective no later than July 1, 2025; and

WHEREAS, Megan Norberg and Glenna K. Frank have each served as an Assistant City Attorney and both have demonstrated experience and abilities well suited to the position for which each is recommended; and,

WHEREAS, also due to the retirement of the Chief Deputy City Attorney no later than June 30, 2025, the Legal Department has been authorized to designate a new Chief Deputy prior to the incumbent's departure to enhance training opportunities; and

WHEREAS, Deputy City Attorney Thomas G. Fisher, Jr., has served as the Deputy of the Intergovernmental Division since April 1 of 2022 and as an Assistant City Attorney since 2014 both in the Litigation and Interdepartmental Divisions and has experience and abilities well suited to the position for which he is recommended.
