## SET HEARING FOR CONVEYANCE OF EXCESS CITY PROPERTY LOCATED NORTH OF AND ADJOINING CARLISLE ROAD TO THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY FOR

FUTURE EXPANSION OF WRA FACILITIES
