## RESOLUTION APPROVING AMENDMENT TO PARKING LICENSE AGREEMENT WITH AMERICAN EQUITY INVESTMENT LIFE INSURANCE COMPANY

**WHEREAS,** American Equity Investment Life Insurance Company (Jeff Varisco, Chief Administrative Officer, 6000 Westown Parkway, West Des Moines, IA 50266) is in the process of relocating and consolidating two office locations with approximately 650 total employees into one location at 1100 Locust Street in downtown Des Moines; and

WHEREAS, in furtherance of the objectives of Iowa Code Chapters 15A and 403 (hereinafter referred to as the "Urban Renewal Law"), the City has undertaken a program pursuant to the Urban Renewal Plan for the Metro Center Area Urban Renewal Project (the "Urban Renewal Plan") to stimulate economic revitalization for the downtown area; to make use of under-utilized areas of the City; to preserve and create an environment within the downtown area which will protect the health, safety, and welfare of the City; and

WHEREAS, the AEL relocation furthers economic development objectives to strengthen the downtown area of Des Moines as the business, financial, and administrative center of the metropolitan area by ensuring high quality job retention in the downtown area of the City which will protect the health, safety, and general welfare of City residents and expand taxable values of properties within the Project Area; and

**WHEREAS**, on June 3, 2024, by Roll Call number 24-0833, the City entered into an Urban Renewal Development Agreement and Parking License Agreement with American Equity that included a minimum of 120 parking spaces in the 1200 Mulberry or 9<sup>th</sup> and Locust parking ramps; and

**WHEREAS**, the City anticipates transferring ownership of the 9<sup>th</sup> and Locust parking ramp to another entity which will remove parking spaces in that garage as an option under the existing agreement with American Equity; and

**WHEREAS**, the parties desire to amend the Agreement to reflect removal of the 9<sup>th</sup> and Locust parking ramp as an option for parking spaces under the Agreement and will also authorize American Equity to lease an additional 100 parking spaces in the 1200 Mulberry parking ramp on a month-to-month basis; and

**WHEREAS**, a copy of the Amendment is included herewith and on file in the Office of the City Clerk for public inspection.
