APPROVING MEMORANDUM OF UNDERSTANDING WITH REBUILDING TOGETHER GREATER DES MOINES, INC. D/B/A REBUILDING TOGETHER TO SUPPORT HOMEOWNERS USING THE ION HOMEOWNER RENOVATION PROGRAM

WHEREAS, Rebuilding Together Greater Des Moines, Inc. d/b/a Rebuilding Together ("Grantee") is working with Improving Our Neighborhoods ("ION") to serve homeowners that are utilizing the ION Homeowner Renovation Program, a City-funded home and property repair assistance program serving income-qualifying homeowners (the "Project") in accordance with a Memorandum of Understanding between Grantee and ION; and

WHEREAS, on or about May 22, 2023 by Roll Call No. 23-0745, the Council approved a Grant Agreement and Memorandum of Understanding between the City and Grantee; and

WHEREAS, on or about July 15, 2024, by Roll Call No. 24-0968, the Council approved a Grant Agreement and Memorandum of Understanding between the City and Grantee; and

WHEREAS, the parties now wish to enter into a new agreement upon substantially the same terms as the prior agreements in order to continue the Project for another annual period

WHEREAS, continuing the Project will serve the public purposes of strengthening and revitalizing neighborhoods, keeping Des Moines residents in their homes, and preventing Des Moines homes from deteriorating beyond repair; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City.of Des Moines, Iowa, that:

- 1. The Memorandum of Understanding between the City and Grantee for the Project for a grant not to exceed \$100,000 is hereby approved and, subject to the Legal Department's approval of the Agreement as to form, the City Manager or his designee is hereby authorized to sign the Memorandum of Understanding on behalf of the City.
- 2. The Neighborhood Services Director or his designee is hereby authorized to administer the Agreement.
- 3. The Finance Director or his designee is authorized to disburse funds pursuant to the terms of the Agreement upon requisition by the Neighborhood Services Department.
