APPROVING AGREEMENT WITH THE U. S. GEOLOGICAL SURVEY FOR THE OPERATION AND MAINTENANCE OF FIVE STREAM GAGING STATIONS, AND AUTHORIZING NEGOTIATION AND EXECUTION OF COST-SHARING AGREEMENTS WITH CITY OF WEST DES MOINES AND DES MOINES WATER WORKS

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA, that the Joint Funding Agreement for Water Resource Investigations ("Agreement"), in the amount of \$67,220.00, between City of Des Moines and the U.S. Department of Interior – U.S. Geological Survey, which provides for the operation of the City's five gaging stations (Walnut Creek, Four Mile Creek, Fleur Drive on the Raccoon River, 63rd Street on the Raccoon River, and 2nd Avenue on the Des Moines River), for which the City of Des Moines will contribute \$67,220.00 and will negotiate with the City of West Des Moines and the Des Moines Water Works for cost-sharing, to cover budgeted costs for the period from October 1, 2025, to September 30, 2026, is hereby approved.

BE IT FURTHER RESOLVED that the Mayor is authorized and directed to sign the Agreement and the City Clerk to attest to the Mayor's signature.

BE IT FURTHER RESOLVED that the City Manager or designee is authorized and directed to negotiate with the City of West Des Moines and the Des Moines Water Works for cost sharing of the City's payment under the Agreement, and to approve and execute cost-sharing agreements with said entities following approval as to form by the Legal Department.
